The ACT Criminal Justice Statistical Profile (the Profile) is a historical series of crime data that is compiled twice a year by the Legislation, Policy and Programs Branch (LPP) of the ACT Justice and Community Safety Directorate and then tabled in the Legislative Assembly.

The profile contains data from the following agencies:

- ACT Policing;
- ACT Ambulance Service;
- Canberra and Calvary Hospitals" Emergency Departments;
- ACT Sobering Up Shelter;
- Domestic Violence Crisis Service;
- Restorative Justice Unit;
- ACT Magistrates Court;
- Supreme Court of the ACT;
- Access Canberra;
- Office of Children, Youth and Family Support, Community Services Directorate;
- ACT Corrective Services;
- Galambany "Circle Sentencing" Court;
- Victim Support ACT.

The Profile provides Government, community agencies and the public, with data on varying levels of crime in the ACT and the responses to crimes by the criminal justice system.

# What's new

## *ACT Policing Tables*

ACT Policing (ACTP) Table 21 reports 5 year trends on all Criminal Infringement Notices (CINs), which are on the spot fines for various misdemeanours, many related to public order offences and alcohol or other drug consumption. This table presented incorrect data in the September 2015 Profile and was not provided in the March 2016 Profile. ACTP and JACS have reviewed the data for ACTP Table 21 and both agencies are now satisfied with the quality of the data on CINs.

## *Galambany "Circle Sentencing" Court Tables*

Data for the Galambany "Circle Sentencing" Court is being internally reviewed and will not be released in the September 2016 Profile.
