DECISION ON FREEDOM OF INFORMATION ACCESS APPLICATION

I refer to your application under the [Freedom of Information Act 2016](#) (the Act), received by the Justice and Community Safety (JACS) Directorate on 15 February 2021 in which you sought access to:

- 1. the location of the ambulance when it was parked before it was going along Torrens Street at Braddon at about 7:18 PM on Sunday, 14 February 2021*
- 2. a list of applications used to identify me and my location.*

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Decision

This letter is to formally advise you, in accordance with section 53 of the Act, that JACS does not hold information within the scope of your request.

53 Content of notice – information not held by respondent

If an access application relates to government information that is not held by the respondent, the decision notice must state that the information is not held by the respondent.

Please note the following information regarding your request:

1. ACT Ambulance Service vehicles are only tracked when cases are assigned to the vehicle. Searches were performed for the time frame of 18:52 to 20:03 in the North Canberra area and no cases were recorded.
2. A specific address can only be identified if the '000' call is received from a landline. If a '000' call is received from a mobile phone, Emergency Services can only obtain the latitude and longitude details which informs vehicles of the nearest cross street.

Online publishing – disclosure log

Under section 28 of the Act, JACS maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the JACS disclosure log no later than 10 days after the decision. Your personal contact details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in the JACS disclosure log, or a longer period allowed by the Ombudsman.
